## Strategic Growth Committee- David Parrillo, Chair

Parrillo reported on the ½ day meeting with the staff to define the biggest priorities for the next three years. They did not focus on how you would do it, but what would stand in your way, what would help you get there or something that would trip you along the way. Now the work begins on how you identify these goals.

## Dorrien and staff looks at the strategic initiative to form a vision... What are the strengths and weaknesses associated with the organization?

Start with programs where we can serve unmet needs and where we can bring in surplus funds. This needs to be ongoing grant funded programs. One of these is the Great Start Readiness Program in Isabella County so we can serve Midland County kids better in two classrooms. WMFC expanded to St. Vincent's Catholic Church in Shepherd. Now we are asking for another classroom in Isabella County, They have the space for us and the slots for us; it is the ongoing funding that we would need. We need to find enough kids to justify it and unlike Midland County, Isabella County isn't as poor because of the reservation. There have been 8 people who have applied for the program and their income is too high.

The next goal in the group is develop one program to fill in the gap in drop in program age base. This age has not been determined; this is something the group needs to work out and that is likely to be controversial for our staff.

Next is to expand the base of our 2013 unrestricted funds. The Challenge Grant ends at the end of 2015.

WMFC needs a preventative maintenance program that is strictly enforced.

Complete a funding program and building expansion to accommodate the need:

- 1. Plan expansion basic program and security requirements 10-15 years based on a written assessment.
- 2. Make sure the community involvement and input is given to the top five programs, being defined by today's participation.
- 3. Reduce utility costs with alternative energy solutions, both in the base and new facilities to be defined.

Form a collaborative group or groups both in funding and participation that is consistent with our core values and demonstrates the synergy in working together.

#### WMFC Strengths:

Diverse in Synergistic in the staff. Trusting positive relationships with the community. Strong track record with funding agencies. Significant accomplishments to date within our community. Passionate hard working staff. Financial and fiscal responsibility.

## WMFC Weaknesses:

Our west reputation makes it more difficult for people to understand our true broader community impact.

Quantitative community program evaluation and assessment.

A clear understanding of the Center for the people who don't utilize the services.

Minimum wage.

Health care.

State Preschool allocation process.

General foundation Status – the younger generation is taking over and they don't live in Midland. WMFC finds the money so others don't feel compelled to give.

Uncertainty in OSHA, Childcare licensing, etc...

Economic uncertainty during the funding and building project.

Threat key staff turnover.
