- Midland Area Community Foundation has asked us to make another request for the solar project next year, they will be restructuring their grant requests for energy projects only. They did not feel it was right to have the energy requests compete against requests that are family or community grants.

- Approved the lump sum salary adjustments and raises for staff over the last couple of months many very appreciative staff came to Greg and Jason to say thank you.
- Last year (2018) we did look into the Michigan non-profit salary survey and compared what we were paying our staff, we feel we are where we should be with staff pay rates for non-profits.

- The Family Focus, year-end letter and letters to Midland Daily News have gone out in the last couple of months letting the community know what we have been doing.
- B & B helped design the Cathy Ring memorial plaques that are in each preschool classroom. The memorial has purchased a book shelf, books, seating and more. Money has also gone into the endowment fund to continue buying books for the children for years to come.
