 - All full time leadership staff express wanting to stay 4 -15+ years
 - The new Human Resources handbook was adopted in January 2017.
 - There should be an expansion of the middle and high school programing.
- Susan was commended by the Board and Executive Director for working with the various staff and volunteers to pull together this comprehensive living document that will serve as a road map for further development.
