WMFC can call the loan at any time, which in turn the dental center would have to find a different loan to pay WMFC off. This loan will help the dental center not have to wait for their incoming monies (Medicaid payments) to pay their monthly payments. They have written grants to help get them in a position that they will not need to wait for those incoming payments.
