# Strategic Growth Committee- Dave Parrillo, Chair

- Reviewed the packet of possible expansion plans and the survey of what the community would like see here at WMFC the board discussed/had questions as we reviewed layout of the building and the survey that will be handed out to program users & community members. Asked the board to look at the list of possibilities and let Greg know if there is something on the list that they feel should be removed or add something they feel we may have missed.
- Earl Soules has volunteered to lead the building project with no cost to WMFC.
- Met with HH & GA Dow Foundation, they are interested in hearing from us for another matching grant and a building request in 2016. Greg would like to have a commitment from them, then go to the other foundations to help if needed.
- Would like to see the board approve funds to go ahead with the building "planning" if Three Rivers does not give the designing of the building with donated time.
- Would like to investigate a water line coming from Lee Township & a fire suppression system and possibly have this be part of the expansion (Bob Dostal is interested in helping with this). Looking at having variable speed pumps for the water wells and the pool to save energy.
- Also interested in a Geothermal heating system and LED lighting through the building (inside & out) to help with energy costs.
- Maintenance software is up and running, it is giving us reminders on routine maintenance. We will be adding more reminders to help with keeping the building in good working order.
- Planning on keeping the modular, the staff use it for meetings, trainings and back-up room for children's programs.
- Working together collaboratively with other community agencies will benefit WMFC, if we can pull together to help provide a service to community transportation as an example. Funding sources like to see groups work together for a common cause.
- The board will continue to monitor the progress of the planning at each meeting, the board will get involved as needed. A schedule we be created to keep the planning on track which will include the investigating of the water and geothermal heating system.
- By November 2015 want to the proposal to the board and get an a yay or nay at the meeting.
