I've been a member of the WMFC Board of Directors for six years. I was drawn to this organization while my oldest daughter, Mikayla was in preschool. At that time I witnessed the impact that the WMFC Preschool program has in the lives of children and their families. As my wife Jill and I volunteered in the classroom, we learned that the program is so much more than a venue to increase academic readiness. Although a member of the West Midland community, I saw for the first time the pervasive poverty that dictates the lives of so many of these little children.

Over time, and through my participation in Parent and Family Nights, I realized that WMFC has really "stepped up to the plate," providing a full spectrum of human services to these families. I was surprised to learn that the human services model and wrap-around assistance is not limited to the preschool families. Any individual or family that participates in WMFC programs is eligible for a number of support services. I am indeed bought into the excellent education provided at the Center but it is the shared "heart" that makes WMFC such a special place. When the time came we jumped at the opportunity to enroll our other children, Callen, Maxton and Jacey in the WMFC preschool. Jill and I have been actively involved ever since.

I did wonder how a non-profit organization was able to provide such a vast array of services. Through my involvement on the WMFC Board I've learned that it isn't easy. It's a constant struggle to maintain a balanced budget and provide the services that are desperately needed by the families. A combination of creative fund raising strategies and unsurpassed staff dedication go a long way to make ends meet. However, I've come to

truly value donors and the army of community volunteers as the bedrock of this unique non-profit organization. Often I think that people minimize the impact of their contribution, be it in the form of a check or in their gift of time. They give because they are called to do so, because it's the right thing to do, because they care or because it's the end of the year. What motivates them to give is unimportant.

But I suspect however, that contributors rarely consider that when they enroll in this "Family of Donors," they protect programs that protect our community's children and elderly. April Is National Child Abuse Prevention Month

Prevention organizations across the nation dedicate April to creating public awareness and understanding for the value of prevention efforts to the safety of our nation's children. The need to increase public awareness to the importance of ensuring the safety and welfare of children led to the first Federal child protection legislation - the Child Abuse Prevention and Treatment Act (CAPTA), in 1974. Although CAPTA has been amended many times over the years, the original legislation remains intact. WMFC patrons have been beneficiaries of this legislation through CHILDREN'S TRUST FUND grants that


allow WMFC to run prevention programs that strengthen family bonds and protect children.

What is Prevention? Increasingly, prevention experts are examining the personal, familial, and environmental matters that strengthen families and reduce the risk of abuse and neglect. Research shows that while some situations negatively impact children and families, others can alleviate negative effects and provide benefits to parents and children. The following bullet points show some successful family support activities that researchers

deem effective as part of a child abuse prevention program. These attributes enhance protective factors. The italicized descriptions, demonstrate how WMFC addresses these activities:

• Parental confidence and knowledge: Through a Family Mentor program, we have a means for parents to get support regarding parenting issues, including: parenting classes, support groups and home visits.

- Strong bonds between parents and children: We provide opportunities for parents and children to engage in activities just for fun and give families reason to laugh together.
- Family social connections to decrease isolation: We offer opportunities for parents in the neighborhood to get to know one another and develop support systems. We have potlucks, classes and encourage parents to take volunteer and leadership roles.
- Family knowledge of child development: Parent education classes provide important information associated with



all aspects of child rearing including an understanding of reasonable expectations for each age group.

- Concrete support in times of need: We provide for a family's basic needs, offer extra support to families when they need it, as in times of illness, job loss, housing problems and other family stressors.
- Children are socially and emotionally capable: We help children articulate their feelings and get along with others. When children bring home what they learn at the Center, parents benefit as well.

When a parent treats a child with respect, love, and understanding, it affects the child for a lifetime—making it easier for children to develop and keep friendships, succeed at school and work, sustain a happy marriage, and parent, effectively. We focus on the efforts that will prevent abuse or neglect from happening in the first place.
